Key requirements are:

#### 1) Developing strategic connections and networks

- Ability to advocate and open doors for the Programme through existing networks
- Well connected with understanding of sustainable business networks in AU and NZ.
- Ability to promote EPDs benefits and advocate for the use of EPDs in sustainable purchasing tools and processes, including green government procurement.

#### 2) Marketing, communication, brand development
