



MOTION: AGM TIMING

Clause 18.1 of the <u>LCANZ Rules</u> state: "The AGM shall be held in June or July in each year at a time and at a place to be fixed by the Committee."

The annual accounts are presented to members at the AGM and circulated 5 days in advance. LCANZ's financial year closes at the end of May. This results in a short timeline to finalise the accounts and creates undue time pressure. We propose to loosen the timings slightly to remove this pressure.

It would be logical to allow for virtual and mixed AGMs in the future (providing contingency and also flexibility for members who do not wish to travel or attend an in-person event) and to include this in the current rules change, although the preference would generally be to include an in-person option where possible.

I therefore move that clause 18.1 of the LCANZ Rules be amended to:

"The AGM shall be held annually within 3 months of the close of the financial year at a time and at a place to be fixed by the Committee. The AGM may be held virtually using a suitable online meeting platform."
